## **Regulations**

on the procedure for conducting sanitary and anti-epidemic (preventive) measures  
at the 50th International Tournament FS-WW "MEDVED"

The COVID19 pandemic has caused general danger in the world, spreading at a high speed, causing great consequences for the health of the population, human casualties and great economic problems. Unfortunately, apart from vaccination and measures of physical distance with the use of a protective face mask, at the moment, there is no effective cure. In this situation, life must not stop, not even sports events. That is why a way should be found to reduce this danger to a minimum and protect the health and life of athletes and other participants in competitions.

### ***1. General Provisions***

1.1. The present Regulations on the procedure for conducting sanitary and anti-epidemic (preventive) measures during the 50th International Tournament "Grand Prix in FS and WW Wrestling "MEDVED" (hereinafter - IT) was developed to counter the spread of coronavirus infection and ensure the safety of the IT in the context of the COVID-19 pandemic.

1.2. International Tournament participants include athletes, team representatives, referees, medical personnel, volunteers, employees of the sports facility, as well as other persons involved in the preparation and conduct of IT. The sports facility is understood as the premises of the state cultural and sports institution "Chizhovka-Arena" (hereinafter referred to as Arena).

1.3. The requirements of these Regulations apply to all IT participants.

1.4. The Organizing Committee has the right to impose sanctions on any Tournament participant who does not adhere to restrictive measures and requirements of these Regulations, for example, revocation of accreditation, a ban on participation in the tournament, a ban on visiting the Arena until a new negative COVID-19 test is received, etc.

### ***2. The principles of organizing sanitary and anti-epidemic (preventive) measures in the preparation and conducting of International Tournament***

2.1. Compliance by all participants with hand hygiene rules, respiratory hygiene rules (sneezing, coughing), mask regime, as well as social distancing.

2.2. Compulsory wearing of masks during the entire stay in the Arena. Exceptions (only for athletes) are training and competition times.

2.3. In the absence of masks, participants are not allowed to the territory of the Arena.

2.4. Access to the Arena for persons not associated with the organization and conduct of the Tournament is prohibited.

2.5. Any activities that require active interaction of a group of people will be minimized.

2.6. Organization of a daily “inlet filter” to the Arena with temperature control, polling for signs of respiratory diseases in order to prevent persons with signs of a respiratory infection (cough, fever above 37 C, etc.).

2.7. Organization at the entrances to the Arena of places for treating hands with skin antiseptics intended for these purposes (with an ethyl alcohol content of at least 70% by weight, isopropyl alcohol at least 60% by weight).

2.8. Organization of regular wet cleaning of the venue at least 2 times a day (before and after the competition day) with the use of detergents and 1 time (at the end of the day) with the use of disinfectants approved for use in accordance with the manufacturer's recommendations for virucidal (effective in against viruses) regime, paying special attention to the disinfection of door handles, handrails, equipment, sports equipment and equipment, and other contact surfaces.

2.9. Organization of a “clean zone” on the territory of Arena, access to which is allowed only to persons who have a negative test for COVID-19. The movement of the delegation members is limited to the “clean zone” at the Arena, airport, transport, hotel.

2.10. Organization of one-time testing of teams for the detection of SARS-CoV-2 antigen upon arrival at the accreditation site. Obtaining accreditation to participate in competitions only after receiving negative test results.

2.11. The team doctors carry out daily medical examinations of the team representatives with thermometry.

### ***3. Requirements for admission of participants to International Tournament***

3.1. All athletes and personnel must undergo PCR testing no earlier than 72 hours prior to arrival in the Republic of Belarus.

3.2. The test results must be kept by the team upon arrival in the Republic of Belarus and during the entire event. All test results must be presented at the airport and at the accreditation center.

3.3. Athletes and team personnel with a positive PCR test result are not allowed to participate in the Tournament, as well as to the training process.

3.4. Before the start of the competition, all members of the delegations (including the national team of the Republic of Belarus) will undergo rapid testing for the

detection of the SARS-CoV-2 antigen. Obtaining accreditation is possible only if the test result is negative.

#### ***4. Organization of transport services***

- 4.1. Each visiting delegation will be provided with a vehicle (bus).
- 4.2. All vehicle surfaces are cleaned and disinfected daily.
- 4.3. All passengers must wear masks.
- 4.4. When entering the vehicle, passengers must be obliged to disinfect their hands.
- 4.5. All vehicle drivers are required to wear masks and test negative for COVID-19.

#### ***5. Accommodation of teams at the hotel. Organization of the Catering***

- 5.1. At the hotels, the necessary measures are being developed and taken to comply with the rules of hygiene and sanitary safety in order to limit the spread of COVID-19.
- 5.2. There is a social distance of 1-1.5 meters.
- 5.3. All hotel employees must undergo instructions and training, observe the rules of hygiene and sanitary safety (mandatory wearing of masks, regular hand disinfection).
- 5.4. Measures are being taken to accommodate teams on different floors in the hotel.
- 5.5. All Tournament participants are required to wear face masks when moving and outside their rooms.
- 5.6. Meals for Tournament participants are carried out separately from other guests of the hotel. In hotel restaurants, a distance of at least 1.5 meters is required.

#### ***6. The principles of organizing the work of the Arena during the Tournament. "Clean area"***

- 6.1. During the Tournament, a "clean area" is allocated in the Arena - a special zone intended exclusively for the persons who are allowed to enter the "clean area" by the decision of the Organizing Committee.
- 6.2. Only persons who have a negative test result for COVID-19 with accreditation are allowed into the "clean area".
- 6.3. The "clean area" includes:
  - competition area;
  - warm-up area;
  - room for accreditation;

- conference room;
- changing rooms;
- doping control room;
- medical office.

6.4. List of persons with access to the "clean area":

- participating teams (athletes and team personnel);
- judges;
- medical personnel;
- representatives of doping control;
- organizing committee room.

6.5. The control of the entrance and the order of movements in the "clean area" will be carried out.

6.6. Participants accredited to visit the "clean area" are prohibited from moving to other zones.

### ***7. Algorithm of actions when detecting a suspicious and (or) confirmed case of coronavirus infection COVID-19***

7.1. If a person with a suspicious or confirmed case of COVID-19 is identified among the Tournament participants, the following activities will be performed:

- athletes and / or team personnel with symptoms of illness are isolated in a separate room;
- the organizing committee organizes the disinfection of all rooms and contact surfaces (including public access) within the boundaries of the epidemic focus;
- the team doctor informs the organizing committee about the detection of a suspicious and (or) confirmed case to make a decision on further examination and treatment;
- the team doctor quickly determines a possible contact group for taking measures for their preliminary isolation;
- the organizing committee ensures (within 24 hours) the sampling of material for conducting research on COVID from persons potentially in contact with the patient (or from the entire team);
- in case of a positive result of the study, the team is obliged to immediately inform the organizing committee and receive instructions on further actions. Further

preventive and anti-epidemic measures in relation to the patient (patients) and contact persons are carried out according to the instructions and recommendations of the specialists of the territorial health authority;

– in relation to persons who have been in contact with a COVID-19 patient, a specialist of the territorial health authority investigates the circumstances of the infection and determines the contact group;

– Persons who have been in contact with a COVID-19 patient are isolated for 10 calendar days in separate rooms of hotels.

- There will be PCR tests shall apply only to those selections whose countries require a negative PCR test as a condition for return to the country without imposing quarantine measures. The payment will be by the participants themselves, **the price of PCR testing is 60 Euro per person.**

#### ***8. Awarding ceremony***

8.1. Medals shall be awarded on a special podium. The medals will be presented by the Organizing Committee officials. In doing so, they will not shake hands with the medal holders or each other.

Congratulations shall be performed with a bow and verbally. Medals, plaques and possibly other awards will be presented by the hostesses on a special tray, which the medal holders will personally take and put around their necks.

Keep every participant safe and healthy is our primary responsibility.
